- You are not in a blended marriage with children from previous marriages.
- You have no dependents with disabilities or complex instructions for care.
- You have no complex trust arrangements to control the distribution of your estate after you die, and/or after your children die.
- You do not have a complex estate (complex business interests, trusts, non-Canadian property, etc).
- You do not have illegitimate children that you don’t support.
- You are not disinheriting a family member.

<sup>2</sup> For the purposes of this Price sheet, a “couple” is defined as a spouse or common law partner. The pricing listed reflects what would be considered a “Mirror Will.” In a Mirror Will, each partner agrees to distribute his or her estate, except for specific gifts, to the surviving partner. When the surviving partner dies, or if both partners die at the same time, the Estate may go to their children in equal shares or, if there are no children, to other beneficiaries in equal shares. In Mirror Wills, the partners acknowledge that the surviving partner has the right to change his or her Will.

<sup>3</sup> A “Wills Package” includes a Will, Power of Attorney, and Personal Directive.

<sup>4</sup> The Estate Fee includes Alberta Court of Queen’s Bench Probate or Grant of Administration Fees and Alberta Land Titles Transmission of Land Fees (if applicable).
